There are three different ways that sharks carry their young. There's ovoparity where the eggs are protected by an egg case and the shark deposits the egg case in a rock crevice where her duty as mother is done. Then there's viviparity where the mother carries the embryo and gives birth to live shark pups. Lastly there is ovoviviparous sharks which combines the first two methods. They produce eggs and the eggs are carried within the female. When the egg hatches, the shark pup continues developing. In this method the first pup will eat all the other eggs and embryos.

MARSHFIELD – On a sunny day earlier this week, Joseph McDonald stopped along Circuit Avenue in the Rexhame Terrace neighborhood, where an unmarked, unpaved, one-lane track led through the trees.

“This is how you get there,” he said, pointing east toward Rexhame Beach. The lane is officially the Winslow Avenue Extension. Barely wide enough for a car, it ends at a parking spot near two shingled houses.

From there, beach goers must walk along the edge of a high hedge, between a sundial and bird bath, and down a winding, pebbled path to the dunes and sand.

It's easy to drive past the Circuit Avenue turnoff without noticing the Winslow extension – but now the obscure little road has become the latest focal point of a 16-year legal battle over access through the Rexhame Terrace streets to the beach.

McDonald asked to speak on the issue. He said two dozen or more concerned residents may attend.

He also wants to discuss a fence and locked gate that a Kent Avenue resident put up to block a beach path there. The gate isn't on town land.

“No one knows about it,” McDonald said of the Winslow path. “So people are going to walk down Kent and find out they can't get to the beach.”

He said “hundreds” of beach goers used the Kent Avenue path on the Independence Day weekend.

The long-running dispute appeared to have been settled on New Year's Eve 2014, when a state Land Court judge ruled that the Winslow extension and beach are town-owned, public property. But plaintiffs filed an appeal.

Four other adjacent streets between Circuit Avenue and the beach were ruled private – including Waterman Avenue, McDonald's street, as well as Kent Avenue and two others.
