JANUARY ACTIVITIES

The Annual Sober-up Dive will be held at Pleasure Bay, South Boston at 10:00 AM on January 1. We usually have a good turnout for this dive, and a lot of lobsters are taken, so come show how brave you are! It will be BYOB as usual, and it would be greatly appreciated if you bring something to eat as well. To reach the Walkers' take exit 15 from Route 3 (Durby Street Hingham/Weymouth) and turn toward Weymouth. Pass "Entering Weymouth" sign (700 ft) and turn left at the first street, Tamarack Trail. It will be the first house on the left, marked by a dive flag. If you get lost call 335-3304.

PAST EVENTS:

The Annual Sober-up Dive, January 1 at Pleasure Bay. Twenty-five divers and many spectators enjoyed the dive. The water temperature was 39°F, the winds were calm, the sun was out, visibility was about ten feet (good for the lagoon) and many lobsters were caught. Mike O'Keefe's 9-7/8 pound lobster topped the scales to begin this year's largest lobster competition. But then came the surprise: after the game warden measured and weighed the lobsters, the MDC police made all divers return their lobsters to the water, citing a rule that prohibits anyone from taking lobsters from MDC waters. Adding to the confusion, the game warden said that 1991 lobster licenses were not valid, but he did not issue citations.

Since the dive Angelo has looked into the regulations regarding lobstering in Pleasure Bay. Angelo found that the MDC does not have any rules or laws regarding lobstering they only enforce the laws of the Department of Marine Fisheries, furthermore, there are no lobster sanctuaries in Massachusetts. Angelo also found that the Department of Marine Fisheries allows a 1 month grace period from the time new licenses are mailed...for this year 91 lobster licenses are valid until February 1st.

After the dive, Bill and Marlene Walker hosted the club for a New Year's Day

party. Approximately 70 people swapped lobster tales (not tails). The food was great; Alfredo's II made fried calamari in the kitchen, while others tasted lasagna in the dining room and chili in the sun room. Marlene reported that when the food was gone, Joe Gomes was the last to leave. The Club thanks Bill and Marlene for a great time.

January 19th Marblehead Light. Nine divers braved the cold only to find it warmer in the water than in the parking lot. The water temperature was 32 and the air temperature was about 15°F. The visibility was 35 feet. Divers came a shore with scallops and one lobster.

FEBRUARY EVENTS:

February 1st Banquet. This year's banquet will be at the King's Hill Function Hall in Braintree. Hopefully you have talked to Marty by now. Cocktails will be at 6:30pm and dinner seating at 7:30pm. the Gannet Grill, Gannet St. Scituate. Directions: from Quincy: Route 3A South, left onto H.T. Bailey Road (Golden Rooster sign). This will turn into Gannet St. Follow Gannet St. to the end. Turn left onto Glades Rd. Follow Glades Rd. to the end, Strawberry Point is through the gate. From the south; Rt 3A North, turn right on Booth Hill Road, this will turn into Gannet St. and follow as above.

February 16th, Ice Dive at Granite Rail Quarry, Quincy. Breakfast at 7:00am at Howard Johnson's at the South Shore Plaza, Braintree. The dive will be at 10:00am. Granite Rail Quarry is located off the old dump road adjacent Mister Tux on the Furnace Brook rotary at the Southeast Expressway. Plan on arriving early to help with set-up. Tentatively scheduled for the February board meeting is an ice diving orientation slide show and talk by Bill Walker and Bruce Gerhard. Bill Walker reminds us that this a fresh water dive so lighten your weight belts by at least 5 lbs.

February 25th and 26th, Basic boating navigation course, 8:00 pm, at the Civil Defense building, 55 Sea St., Quincy. The course will be taught by Jim Walker, members and guests are invited. Plan on attending both nights.

February 29th, Boston Sea Rovers Show. This year's show will be at the Westin Hotel. Members are needed to help man and transport the club booth - contact Angelo if you can help out.

CHEF'S CORNER

Clams Casino **Yield 10 servings**
Requested by Rob O'Bryan

Bacon, diced - 4 oz.
Onions, minced - 4 oz.
Green peppers, minced - 3 oz.
Red peppers, minced - 3 oz.
Salt, to taste
Pepper, to taste
Worcestershire sauce - to taste
butter, softened - 1 lb.
top neck clams - 6 per serving
bacon, whole strip, blanched, quartered, 1 per portion

Method:

1. Render the diced bacon until it is crisp. Add the onions and peppers and saute them until they are tender. Remove them from the heat and allow them to cool.
2. Combine the onion and pepper mixture with the salt, pepper, Worcestershire sauce and butter. Blend all ingredients until they are evenly mixed.
3. Open the clams and loosen the meat from the shells. Top each clam with one teaspoon of the butter mixture and a piece of quartered blanched bacon. Broil the clams until the bacon is crisp. Serve immediately.

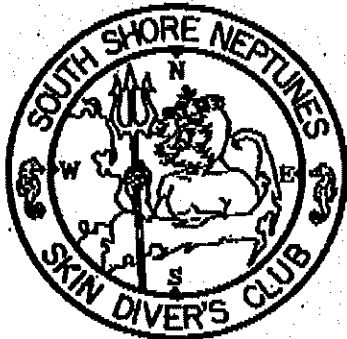

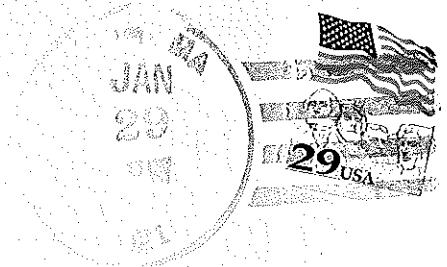

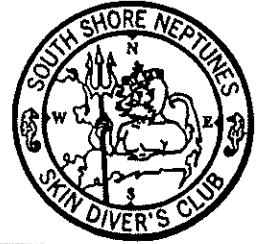

PAST EVENTS:

After the dive Alan Pugh brought the party on a tour of Gloucester looking for a Mexican restaurant that turned out to be in Marblehead. Maybe Alan will find the restaurant for the April 5th dive.

March 15th, Pemberton Pier, Hull

The weather was cold and clear as ten divers entered the water. The water temperature was reportedly 32-34°F, but only Bill Burchill knew for sure because the wrist seal on his dry suit ripped. There was only one lobster taken and no one found any good junk, but everyone had a good dive.

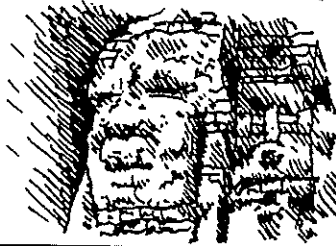

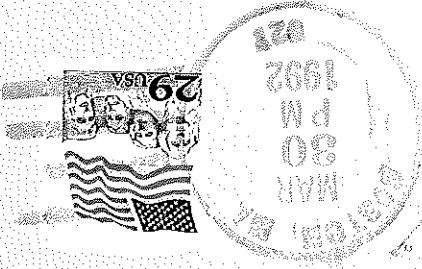

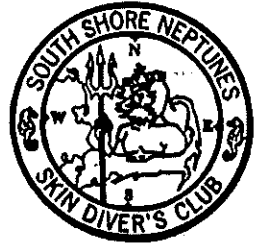

24. Plan your dive carefully and follow the plan.

2. That a list of recommended safety equipment be added as follows:

Recommended Safety Equipment

- Tank pressure gage
- Depth gauge
- Knife (must be sharp)
- Whistle
- Timing device (bottom timer or watch)
- Buoyancy compensator (life vest)
- Snorkel
- Dive tables and/or decompression computer
- Diver's flag

3. That the words "power inflating" be deleted from Club Rule E. 2. on page 16 of the club book.

Members of the safety committee will be available at the Clubhouse at 7:00 pm on May 12 (before the May Board meeting) to answer questions about the changes.

The recommended changes will be voted on by the membership on May 19, the second general membership meeting of May.

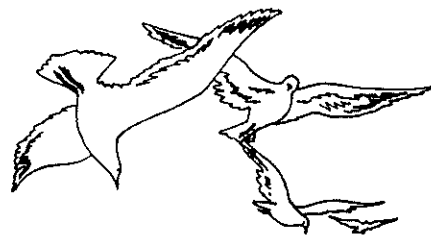
